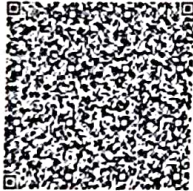

BABA MASTNATH UNIVERSITY, ASTHAL BOHAR, ROHTAK (HARYANA) - 124021, (herein referred as 'Party No-I' which expression unless repugnant to the context shall mean and include its successors and assigns) of one part;

AND

GREEN EARTH – ORGANIZATION FOR ENVIRONMENT, HEALTH, SAFETY & SANITATION (Key Resource Center & Sector Partner – GoI, Ministry of Jal Shakti, Department of Drinking Water & Sanitation), Shopping Complex, Teka Market, New Shanti Nagar, Kurukshetra – Pehowa Road, Kurukshetra, Haryana - 136118 (herein referred as 'Party No -II') of other part;

The Party -I and Party -II are hereinafter collectively referred to as "Parties" and severally each as 'Party'. This MoU/ Agreement shall be effective from date of signing ("Effective Date").

IT IS NOW AGREED BY AND BETWEEN THE PARTIES HERETO AS UNDER:

1. That both parties will work together for attaining and sustaining goal of 'Single Use Plastics Free - Zero Waste to Landfill and Clean - Green & Pollution Free Campus' in a befitting manner.
2. That the Party-II will provide technical/ handholding support to the Party-I for developing and execution of a low cost & sustainable waste management model(s) for attaining & sustaining the 'Single Use Plastics Free - Zero Waste to Landfill Campus'.
3. That the Party-II will provide facilities/ technical & administrative support to the students (Party-I) for successful completion in their internship in environment related activities.
4. That both parties agreed to extend support of subject experts/ resource persons/ administrative teams/ infrastructure to each – other as and when required for conducting capacity building programmes i.e. trainings, workshops, seminars, symposiums, camps, exposure visits, expert lectures and developing of various behaviour change IEC materials, training module and material development and documentation.
5. That both parties agreed to share the logistic support as and when required for conducting capacity building programmes successfully i.e. trainings, workshops, seminars, symposiums, exhibitions, camps, exposure visits, expert lectures and behaviour change IEC activities on environment protection & conservation including water, air, soil, sanitation & hygiene, health and safety from time to time.
6. That the Party-II will provide handholding support and conduct various training programs/ sessions/ survey/ field studies and behaviour change awareness activities for stakeholders on waste management, sanitation & hygiene, water resources management and safety on 'no profit- no loss basis'. Accordingly, modalities for 'no profit- no loss' may be workout mutually by the both Parties under ambit of this MoU from time to time.
7. That all costs of various materials, infrastructures, workshops/ training sessions/ survey etc and expenditures of visits/ travels of experts (from Party-II) will be borne by Party-I.
8. That both parties may run diploma & certificate courses jointly in the areas of waste management, water resources management, sanitation & hygiene and safety and environment management. Accordingly, modalities may be workout mutually by the both Parties from time to time.

9. That the record of all activities including trainings/ IEC activities and other related works should be maintained in systematic manner.
10. That the names of both Parties will be advertised equally for the activities to be conducted under the ambit of this MoU.
11. That the MoU is signed initially for a period of three years which will be effective from date of signing of MoU. The stipulated period of MoU may further extend up to 3-5 years; however, this extension shall be purely on the basis of mutual consent of both parties.
12. That the parties may terminate MoU with prior notice of three months in writing which will be served at the registered address of opposite party.
13. That terms of MoU may be edited as per need with mutual consent of both parties in written.
14. That if any dispute arises between the Parties hereto during the subsistence of this MoU or thereafter, in connection with matters concerning therewith. The same shall be resolved through mutual consultation in amicable way.
15. That the both Parties will execute the various activities under this MoU on 'no profit – no loss' basis in the greater interest of community and each other.




