2. Jan Seva Sansthan, Bhiwani Road, Rohtak, a non-governmental organization (NGO), dedicated to community service and social welfare.

Objective:

The purpose of this MOU is to establish a collaborative framework between BMU and Jan Seva Sansthan for the effective implementation of the National Service Scheme (NSS) activities. This agreement aims to encourage student participation in community development programs and foster social responsibility.

Terms of Collaboration:
